Previous installments of this presentation were given in 1988, 2000, 2005, and 2006. This presentation updates Private Sector Passenger Car and Light Truck (Class 1 and 2) motor oil consumption and projects out to 2013. Projections are affected by key market condition drivers, including "aging vehicle population due to decreased vehicle production"; "volatile gasoline prices", "extended motor oil drain intervals"; etc. However despite these market condition drivers, there are opportunities for manufacturers to win in this changing market environment.

#### Group II Base Oils: A Valuable Asset for Global Lubricant Formulators Douglas Bea, Chevron Global Lubricants

Ever tightening standards for lower tailpipe emissions, better fuel economy and low SAPS compliance are pushing lubricant manufacturers worldwide to formulate with higher percentages of Group III base oils. This is particularly true for 5W and 0W motor oils. The major additive suppliers, working with Chevron Group II base oils have developed formulations that meet upcoming ACEA and API standards with dramatically lower amounts of Group III base oils.

## **Blending Values of Different Group III Base Stock Slates**

The properties of each Group III base stock slate are determined by the choice of feedstock and manufacturing process. Each Group III base stock slate will respond differently to a particular PCMO formulation. Group II 5W-XX formulations can be optimized with Group III base stock. The right selection of Group III base stocks can minimize the usage of Viscosity Modifier in 5W-30 PCMO formulations.

# Lubricants and Waxes from a Shipowner's Perspective

As refineries shift yields and investment strategies towards diesel production, there will be new opportunities for base oil manufacturers and buyers. Refineries will look increasingly to hydrocracking technologies to provide the needed yield shift.
