How to Register

1. Conference Registration and Tickets

Log on to www.npra.org and select "Meetings", "Upcoming Meetings", "2009 International Petrochemical Conference" then "Register Now" or complete the enclosed registration form. Registration includes admission to the Symposium on Entrepreneurship and Innovation in the Petrochemical Industry, the Welcome Reception, the Opening General Session, the Supply Chain Forum, and the Petrochemical Forum. Order tickets for the International Petrochemical Luncheon. Refer to the registration form for conference and ticket fees.

Note: Ticketed functions are open to registered attendees only. Be sure to register by February 13, 2009 to have your name included in the IPC attendee list in the Program Book. March 13 is the cut-off date to be listed in the registration supplement. Plus, you'll save \$100 if you register by February 25!

2. Hotel Reservations

Reserve your hotel on-line when you register at www.npra.org and receive an immediate acknowledgement of your reservation. Or, fill in the appropriate space on the enclosed registration form. Hotel reservation requests will be processed in the order received by the NPRA. Get immediate acknowledgement on-line but allow 2 weeks if submitted to NPRA. The hotels require a deposit equal to one night room rental plus tax to guarantee your room. The Hilton and Westin Hotels will charge the deposit upon receipt of your reservation in early March 2009. If no deposit information is provided within 30 days prior to arrival, your reservation will be cancelled. Hotel-specific cancellation policies will be printed on your email registration confirmation from NPRA and should also appear on your hotel confirmation. February 25, 2009, is the cut-off date for making hotel reservations, cancellations or substitutions through NPRA or on-line. Beginning March 6, reservations, substitutions, or cancellations must be made through the hotel directly.

3. Spouse Registration

Your spouse may join you at the Welcome Reception as well as the included business sessions by registering for the nominal spouse fee of \$100. A spouse must be registered to purchase a ticket to the spouse tour or the Tuesday International Petrochemical Luncheon.

4. Payment

7. Confirmation

Your registration will be confirmed via e-mail if you provided us your email address. Otherwise, your confirmation will be sent via U.S. mail.

Cancellation Policy: Registration cancellations may be made on-line or submitted in writing, faxed to 202.835.0467 or e-mailed to IPC@npra.org. Substitute conference registrations may be made in advance or on arrival with no penalty. Substitutions must be submitted in writing to IPC@npra.org.

Cancellations may be made by February 25, 2009 with no penalty. Written cancellations postmarked, faxed, or emailed between February 26 and March 13, 2009 will receive a refund of fees, less a \$50 processing fee. No refunds after March 13, 2009. No telephone cancellations.

Ticket Refund Policy: Refunds will be made on individual tickets purchased, if request is received in writing prior to March 13, 2009. No refunds after March 13.

Refunds will be made on tables of tickets purchased, if request is received in writing prior to February 25, 2009. No refunds after February 25.

Ticketed functions are open to *registered attendees* only. All individuals using tickets must be registered for the conference.

Spouse / Guest Policy: A guest is a spouse/ significant other, friend or an adult child (18 years old or older) who is not in an industry-related occupation. A co-worker, an associate or spouse who works within the industry may not use the Spouse/Guest registration category.

Fee Policy: Eligibility for member rates is based on membership information currently on file with NPRA. If your company is not currently a member, the non-member fees will be charged to your credit card.

Registration Policy: Those who are present at the site of an NPRA meeting and/or occupy a hotel room in the NPRA room block to conduct business with industry personnel gathered for that meeting are expected to register for that meeting and pay the registration fee, whether or not they attend a specific function.
