
NATIONAL OCCUPATIONAL & PROCESS SAFETY CONFERENCE AND EXHIBITION

Welding Health Hazard Control in Petrochemical Turnarounds

Mike Harris, Hamlin & Harris, Inc.

This course describes common petrochemical welding and thermal cutting processes and the health/ safety hazards associated with each of these processes. Terminology used in the welding industry is incorporated throughout this course as a means of familiarizing participants with the vocabulary used in the workplace. Materials, thermal processes and scenarios associated with potential for overexposures are described. Emphasis is placed on manganese and hexavalent chromium exposures as well as many other health and safety hazards. Suggestions for improving the quality of monitoring data are provided as are suggestions for prioritizing exposure assessments. Ventilation techniques and respiratory protection options are also described. An Excel spreadsheet for tracking relevant data for developing welding SEG's (similar exposure groups) is provided.

This course is geared toward people with health & safety responsibilities during turnarounds, welding shop supervisors and work permit issuers.

Course Outcomes

Upon completion, the participant will be able to:

- Describe general health and safety hazards associated with welding and thermal cutting;
- Develop an exposure assessment strategy for welding and thermal cutting strategies;
- Recognize and recommend effective ventilation for confined space welding and thermal cutting; and
- Identify issues that need to be addressed during welding and thermal cutting in confined spaces.

OSHA and EPA Regulatory Update

Following the tragic West Fertilizer explosion in 2013, President Obama issued an Executive Order directing OSHA, EPA and other agencies to "modernize" the manner in which the government regulates chemical manufacturing processes. OSHA and EPA are taking sweeping actions in response to this Executive Order, from enforcement initiatives to rulemaking efforts to overhauling OSHA's PSM and EPA's RMP regulations, as well as some controversial backdoor rulemaking by interpretation letters and enforcement positions. This regulatory update will review the PSM and RMP changes we have already seen. and those making their way through the rulemaking process. The presentation will also cover other likely remaining OSHA rulemaking activity we expect over the balance of President Obama's term.

Beginning in early 2014 and continuing into 2015, the facility was struggling with a marked increase in serious near-misses and recordable injuries. Two recordable injuries in the first month of 2015 prompted immediate action. United In Safety, the site contractor safety council, was concerned that an undesired trend was beginning and needed to be reversed. Upon review of the incidents, it was discovered that the injuries could have been prevented with proper hazard identification and mitigation. This presentation describes the actions taken to improve hazard recognition and pre-job task analysis at this site.
